Following the acceptance of the Mass Immigration Initiative in 2014 and the exclusion of Switzerland from the Horizon 2020

framework, a lot of the Swiss Biotech Association's resources were required for lobbying in order to minimise the damage for the biotech sector in Switzerland. Within Europe, the Horizon 2020 framework will invest €0bn from 2014 to 2020 into research and innovation. Switzerland needs to become again an equal partner in this framework which would also support many Swiss Biotech companies.

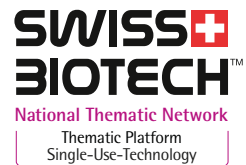
Swiss Technology Hub: A business opportunity in Brazil.



The SICHH is coordinating the creation of a Swiss Technology Hub (STH) in Brazil. This technology hub aims to exchange innovative technologies applicable to human health between Switzerland and Brazil. The main fields of interest are Biotech, Medtech, Foodtech and Pharma. The STH kick-off event will take place from the 8th to 12th of August 2016, during the Olympic Games in Rio de Janeiro. A delegation of 15 members from prestigious Swiss academic institutions and enterprises is being gathered to attend this event. Biotech 2016

Biotech 2016 will take place on 5 and 6 of September in Wädenswil. The topic of the conference is „Biopharmaceutical manufacturing and single-use technologies“ and it focuses on the development and manufacture of biosimilars, cell therapeutics as well as microbial products and single-use production facilities. The conference is organized by the Institute of Chemistry and Biotechnology of the Zurich University of Applied Sciences, the biotechnet Switzerland, the NTN Swiss Biotech and the DECHEMA. In addition to oral presentations, an exhibition on industrial equipment and a poster event are planned. On 7 and 8 of September a post-conference discussing new training concepts for flexible biopharmaceutical productions and a mini-symposium about cultivation of plant cells follows. The innovation promotion agency 'Commission for Technology and Innovation' (CTI) is active in a number of areas: R&D project funding, start-up and entrepreneurship, and knowledge and technology transfer (KTT). In the field of life sciences, the technology and business areas covered are biotech, medtech, agrotech and foodtech.

Special measures 2016

The federal council has approved additional special measures for the CTI's innovation promotion in the amount of CHF 61 M. The purpose of this action is to support export oriented small and medium-sized companies (SME), which continue to struggle due to the effects of the strong Swiss franc. The special measures are limited to the end of 2016 and are complementary to the special measure taken 2015.
